TRIP TERMS**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes: Roundtrip motorcoach transportation from Harrisburg, three nights lodging, room with two queen beds, at the Inn at Holiday Valley, continental breakfast each day, and lift ticket from time of arrival through departure.

Basic package prices: \$521.00 double occupancy; \$753.00 single occupancy. Non- skiers/boarders, deduct \$133/person. Junior Skier/Boarder between the ages of 6 – 12 years old, deduct \$60/person. If you are a teen skier/boarder between the ages of 13 – 17 years old, deduct \$40/person. To participate in the optional trip to Holimont Ski Resort on Friday, February 23, add \$39.00, which will include the bus ride to and from and a lift ticket.

We reserve the right to pass along to trip participants and fuel surcharges levied by the bus line, over and above the originally quoted ticket price, assuming these surcharges are levied before we leave.

PAYMENT SCHEDULE

- \$300.00 initial deposit with application
- Final payment, balance plus any extras requested by January 2, 2018
- Checks should be payable to “SSC” and mailed to trip leader (see contact information below).

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant’s responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- Cancellation prior to November 7, 2017 - \$20.00 fee
- Cancellation from November 7, 2017 through December 5, 2017 - \$100.00 fee
- Cancellation from December 6, 2017 through January 14, 2018- \$300.00 fee
- NO REFUND for cancellation ON OR AFTER January 15, 2018

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
