JANUARY 13-20, 2018**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes 7 nights' double-occupancy lodging at the Ptarmigan Inn, non-stop roundtrip air from Dulles to Hayden, bus transportation to and from airports, daily hot breakfast buffet, group portage, a 5-day lift ticket, a welcome party, and group farewell dinner. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$2,607 single occupancy; \$1,885 double occupancy; \$1,705 triple occupancy; \$1,605 quad occupancy. Optional 6th lift ticket prices for \$48. Non-skier lift ticket deduction \$290.00. Strawberry Park hot springs add \$42. Transportation deduction for seniors, age 65+. Room upgrade options: Add \$30 pp for deluxe room, other room options available.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between Dulles & Hayden. **Land-only prices:** \$2,079.00 single occupancy; \$1,357 double occupancy; \$1,177.00 triple occupancy; 1,077.00 quad occupancy.

PAYMENT SCHEDULE

- \$650.00 initial deposit with application
- \$750.00 second installment by October 15, 2017
- Final payment, balance plus any extras requested by December 5, 2017

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the "REAL ID Act of 2005"**. If there is a discrepancy, minimum name change fee is \$150.00 Any no name space will be released at that time. Requests for name changes after December 6, 2017 will cost \$150 until January 2, 2018 and then cost \$225.

SHIFT FEES: If you cancel after ticketing and find your own replacement, \$150.00 to \$250.00 fee. Name change fees as stated above will also apply.

DEVIATIONS FROM ITINERARY: \$225.00 fee per change + Airline Charges. Plus any difference in the fare until January 02, 2018 (and may not be allowed thereafter).

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to September 2, 2017 - \$40 fee**
- **Cancellation from date September 2, 2017 through November 10, 2017 - \$100.00 fee**
- **Cancellation from date November 11, 2017 through December 9, 2017 - \$300 fee**
- **NO REFUND for cancellation ON OR AFTER December 10, 2017**

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
